Of the total shares of common stock reported herein, 37,616,958 shares (9.66% of the class) are held in Barbey Family Trust accounts for which PNC Bank, National Association (PNC Bank") serves as co-trustee. PNC Bank, as co-trustee, is deemed to share voting power and dispositive power with respect to those 37,616,958 shares.

Of the total shares of common stock reported herein, 33,993 shares are held in accounts at PNC Bank in a fiduciary capacity for clients outside of the above-referenced trust accounts.

Of the total shares of common stock reported herein, 2,259 shares are held in accounts at PNC Delaware Trust Company in a fiduciary capacity for clients outside of the above-referenced trust accounts.
